Immediate family members of PEPs include any of the following relations: i. spouse (current and past) ii. siblings (including half-siblings) and their spouses iii.children (including step-children and adopted children) and their spouses iv. parents (including step-parents) v. grand children and their spouses Close associates of PEPs or their family members includes: a.) a natural person having joint Beneficial Ownership of legal entities and legal arrangements with a PEP or any other close business relationship with a PEP, b.) a legal person or legal arrangement whose Beneficial Owner is a PEP and is known to have been set up for the benefit of such person or Immediate Family Member of a PEP, c.) a PEP's widely and publicly known close business colleagues or personal advisors, in particular, persons acting in a financial fiduciary capacity.
