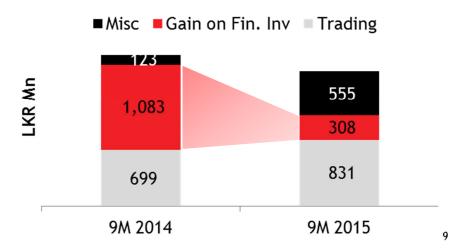

Fee & Commission - Segment-wise



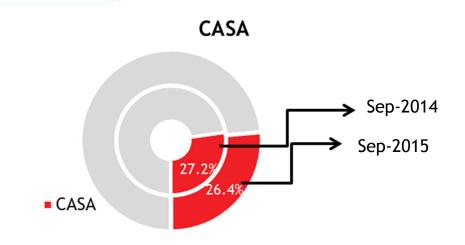

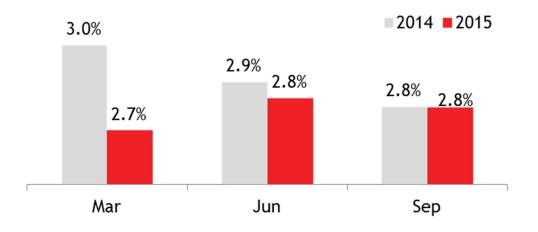

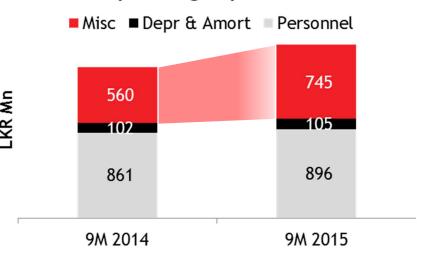

Impairment provision as a % of Gross Loans

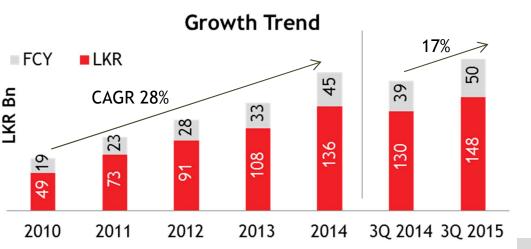

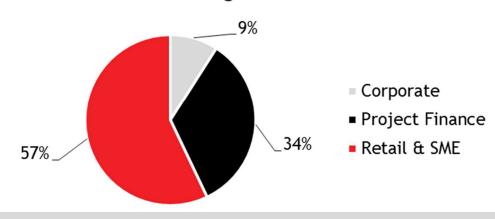




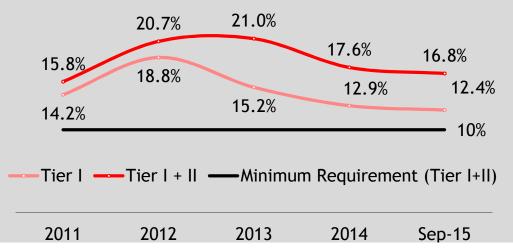
Growing Retail & SME Book



YoY Growth - Segmental Contribution

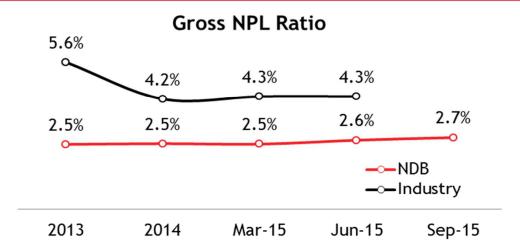


Capital Adequacy Trend

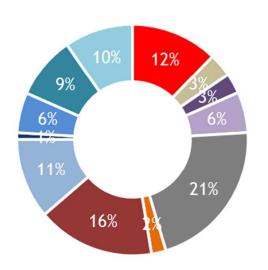

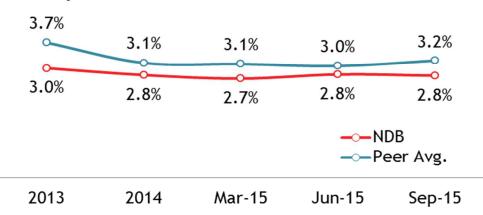

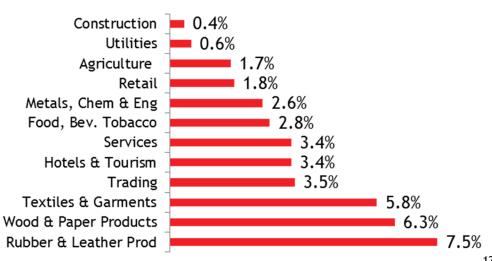

Impairment Allowance: % of Gross Loans

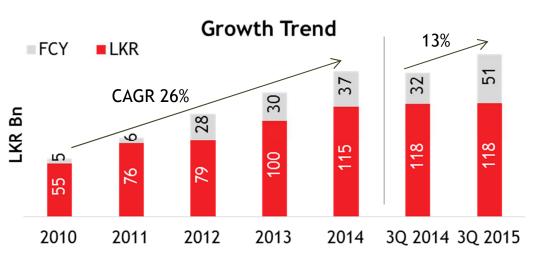


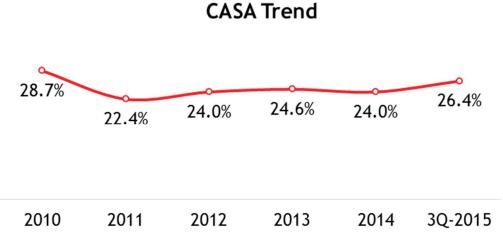
NPL Ratio - sector wise



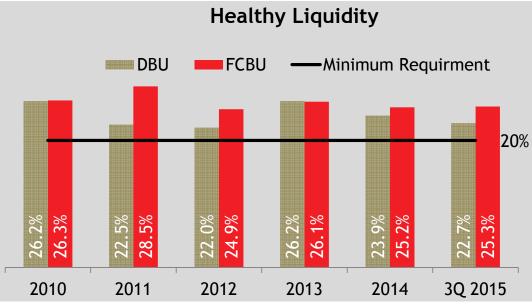
